## Landscape Enhancement

Phase I of the Master Landscaping Plan was completed this past summer. The plantings comprise of mostly native plants that are sustainable, low-maintenance, drought and deer resistant, and produce seasonal colors. We used young plants to stay within budget and will take 1-3 years to establish. The current state is not representative of what they will become once established, which will be vibrant, full, and supportive of wildlife.
